

## Name That Teacher Competition 2018

### Terms and conditions

1. The 'Name That Teacher' prize draw (the "**Competition**") is open to parents and legal guardians or individuals aged 18 years or over who have parental responsibility for children or step children who are between 0 and 16 years of age and who are UK residents, excluding employees of Computershare Voucher Services Limited ("**CVS**"), its group companies or their family members, or anyone else connected with the Competition. We reserve the right to ask for proof of age of the children of entrants to the Competition.

To enter the Competition you must comment on any post relating to the Competition made by Childcare Voucher Services on our Facebook page ([www.facebook.com/computersharevoucherservices](http://www.facebook.com/computersharevoucherservices)) between 00:00 (GMT) on Monday 23<sup>rd</sup> July, and 23:59 (GMT) on Friday 17<sup>th</sup> August (inclusive) (the "**Closing Date**"). Your comment must include your answer to the competition question, the name of the eligible childcare organisation that you wish to receive the prize should you win and must include the hashtag #teacher.

4. By submitting an entry to the Competition (pursuant to paragraph 2 above) you confirm your acceptance to these terms and conditions.

7. There will be one prize and one winner will be chosen at random from all eligible, correct answers. Subject to the remainder of these terms, the winner's nominated eligible childcare organisation will receive a cheque of £1,000.00 (the "**Prize**").

In order to be eligible to receive the Prize, a nominated childcare organisation must be a person or organisation registered with Ofsted in England, (or their equivalents in Wales, Scotland, Northern Ireland), or other relevant governing body such as the Independent Schools Inspectorate that caters for children of school age before and after school in term time and/or during the school holidays. If not registered with the appropriate governing body they are ineligible to be nominated or to receive the Prize. Computershare Voucher Services reserves the right at its absolute discretion to determine the eligibility of a nominated childcare organisation.
9. You or your nominated childcare organisation will need to provide evidence to our satisfaction to demonstrate the eligibility of your nominated childcare organisation to receive the Prize.
10. The winner will be notified via a reply to their Facebook post tagging them within five (5) working days of the Closing Date. The winner must contact us via Facebook to acknowledge our notification within 7 days of our notification being posted. If the winner fails to respond to this post within that time, Computershare Voucher Services reserves the right to re-draw and select a new winner of the prize (in which case the same notification requirements shall apply to the subsequent winner). If a winner or a childcare organisation rejects his or her

prize, then the winner's prize will be forfeited and Computershare Voucher Services shall be entitled to select another winner.
